### 1. Introduction

This plan is based on the [contingency framework for managing local outbreaks](#) of COVID-19 and the [schools operational guidance from step 4](#), published by the Department for Education (DfE).

We will only implement some, or all, of the measures in this plan in response to recommendations provided by our local authority (LA), director of public health (DsPH), Public Health England (PHE) health protection team or the national government.

It may be necessary to implement these measures in the following circumstances:

- To help manage a COVID-19 outbreak within the school
- If COVID-19 infection rates in the community are extremely high, and other measures have failed to reduce transmission
- As part of a package of measures responding to a 'variant of concern' (VoC)

### 2. Testing

If recommended, we will increase the use of home testing by pupils and staff. If it is advised that we reintroduce an asymptomatic testing site (ATS) at our school, we will consult with the director of public health (DsPH) to discuss any further support we need to do this.

If we reintroduce on-site asymptomatic testing:

#### When testing will take place

Testing will take place ~~twice weekly~~ on a Monday & Wednesday morning to ensure the best opportunity for capturing positive cases and isolating accordingly.

#### Where testing will take place

Testing will take place in the designated LFT zones.

#### Who will receive on-site testing?

On-site testing will be in place for all pupils. Staff will continue to test from home to alleviate the strain on the test center resources.

### **3. Face coverings**

If recommended, pupils, staff and visitors who are not exempt from wearing a face covering:

- Will be asked to keep on or put on a face covering when arriving at school and moving around indoors in places where social distancing is difficult to maintain, such as in communal areas
- Will be asked to wear a face covering in classrooms or during activities, unless social distancing can be maintained or a face covering would impact on the ability to take part in exercise or strenuous activity. Pupils may remove face coverings when participating in PE lessons.

### **4. Shielding**

We will adhere to national guidance on the reintroduction of shielding, which would apply to those on the [shielded patient list \(SPL\)](#).

We will speak to individuals required to shield about additional protective measures in school or arrangements for home working or learning.

### **5. Other measures**

If recommended, we will limit:

- Residential educational visits
- Transition or taster days
- Parents coming into school
- Live performances
- External visitors

If recommended, we will reintroduce:

- Zones to reduce mixing between groups

### **6. Attendance restrictions**

Attendance restrictions will only be recommended as a last resort. If recommended, we will implement the measures in this section.

#### **6.1 Eligibility to remain in school**

In the first instance, we will stay open for:

- Vulnerable pupils
- Children of critical workers

When prioritizing year groups we will initially focus on bringing back year 11 students whom will be taking exams during the academic year.

#### **6.2 Education and support for pupils at home**

All other pupils will be required to stay at home and will receive remote education.

We will aim to deliver remote education that meets the same quality and quantity of education that pupils would receive in school, as outlined in our [Remote Learning Plan](#).

The school will continue to provide meals or lunch parcels for pupils eligible for benefits-related free school meals while they are not attending school because of COVID-19 isolation guidelines.

### **6.3 Wraparound care**

We will limit access to before and after-school activities and wraparound care during term time and the summer holidays to those that need it most.

We will communicate who will be eligible to attend once the restrictions are confirmed.

### **6.4 Safeguarding**

We will review our child protection & safeguarding policy to make sure it reflects the local restrictions and remains effective.

We will have a trained DSL or deputy DSL on site wherever possible.

On occasions where there is no DSL or deputy on site, an alternative senior leader will take responsibility for coordinating safeguarding on site.
